Dear Friends,

As we celebrate six decades of commitment to the children of India, we pause to reflect on our hard but satisfying journey. What began as a modest initiative in 1964, has blossomed into a nationwide organisation, touching countless lives and leaving a meaningful impact.

This year has been marked by significant changes and formidable challenges. The evolving landscape of child care necessitated strategic realignments. SOS India's adaptability was amply displayed, as we increased our emphasis on foster care, kinship care, and short stay homes. These initiatives have not only strengthened our ties with the Government but also deepened our community partnerships. We are also partnering with the Government as knowledge partners for training of childcare workers.

In Uttarakhand, we have embarked on a pioneering programme - a community-based model akin to Family Like Care. This approach promotes inclusivity and provides a nurturing environment for children. It is a testament to our innovative efforts.

The recent changes to the Foreign Contribution (Regulation) Act (FCRA) have intensified fundraising competition. Consequently, we have had to resort to some tough cost-cutting measures. This has impacted our ability to take in more children and we have not been able to expand our programmes as we had envisaged. If anything, we have reduced the number of children under our care. It has also affected the annual compensation of

our co-workers and this is for the second time in a row we had to decide against salary revisions. We express heartfelt gratitude to our dedicated co-workers for their understanding and support during these challenging times.

Despite these difficulties, SOS India remains steadfast in its mission. We remain hopeful that our financial position will improve, allowing us to continue our vital work and care for our employees. The role of our donors becomes even more crucial and we hope that they will support us even more in this challenging time.

In this momentous year, we celebrate our achievements—both big and small. Each child's smile, each milestone reached, fuels our passion. We envision a future where every child finds a loving home—a place where dreams take root and flourish.

We sincerely thank you for your support and belief in our work. Together, we will create a brighter tomorrow for India's children!

Message from our CEO

Dear Friends and Supporters,

Founded in 1964, SOS Children's Villages India turns 60 this year. It is a significant milestone that few organisations accomplish, and this makes us very proud. Our 60th anniversary is a celebration of our organisation's legacy; its long journey, who we are today and our exciting future ahead in serving the children without or at risk of losing parental care. We have evolved into a partner of choice for many, transforming vision into value.

It may be easy to say, however, getting this far has been an arduous journey. Compliance to amendments in national laws with regards to alternative care for children, and the COVID-19 global health crisis leading to financial challenges are just the examples. Nevertheless, such challenges have strengthened us as an organisation and enabled us to be more innovative in our programmatic approach for children in need. We have evolved from Family Like Care programme to Basket of Care Solutions that offer tailor-made care solutions to meet every child's unique needs.

During the year 2023-24, the organisation was committed to the implementation of its strategic plans, which allowed us, among other things, to be fully compliant with the 'Mission Vatsalya' guidelines by the Ministry of Women and Child Development, Government of India. This led to the structural adjustments in our Family Like Care model and facilitated reintegration of children having biological roots in their communities. We ensured their continuum of care and development through our existing Kinship Care or Family Strengthening Programme. For greater efficiency and for measuring our achievements in a more scientific manner, we introduced Result Based Management (RBM) across our programme locations during the year. We conducted the national level Child Rights Situation Analysis (CRSA) to take stock of the parentless and vulnerable children in the country for planning appropriate interventions.

Our commitment to operational excellence remains unwavering. We have restructured into two zones, enhancing efficiency and responsiveness. Remote accounting and IT automation have become our allies, ensuring seamless financial management.

Last year presented significant challenges. The fundraising landscape forced us to make tough decisions, implementing austerity measures to navigate the environment. We optimised costs, streamlined operations, reduced manpower, and restructured our organisation to enhance efficiency. Despite these trials, we found hope. Reflecting on the impact we have created over six decades, we remain resolute and ready to take even more significant strides forward. Our robust partnerships with various State and District Administrations have enabled us to reach children and families who need us the most.

Our focus extends beyond immediate care. We are structuring our commitment to vulnerable sections of society through thematic and programmatic interventions aligned with ESG (Environmental, Social, and Governance) requirements.

Our skilling programme equip our youth with the tools they need to thrive in today's competitive environment. We are laser-focused on new-generation courses, preparing them for meaningful careers. Empowering families: Cultivating resilient support systems

Helping vulnerable families become self-reliant to afford quality care for their children

Our commitment is embodied in the Family Strengthening Programme (FSP), which goes beyond mere support. We offer hope and healing, focusing on repairing and fortifying families to ensure they can offer the nurturing environment essential for a child's growth. By empowering families, we aim to make vulnerable families self-sustainable and prevent the loss of parental care and work to strengthen the familial bonds critical to a child's development.

Our programme ensures that children's fundamental rights to education, skilling, health and nutrition are upheld. We collaborate with women from disadvantaged backgrounds, transforming them into primary caregivers who achieve sustainable independence. Through targeted livelihood support and income generation activities, we enable these women to provide stable and loving homes for their children.

From struggle to strength: An inspiring transformation

N. Venkataratnam, a widow from a tough background, tried her best to provide for her kids on a meagre income for several years. But then, in 2018, everything started to change for the better once she was introduced to the Family Strengthening Programme. With income generation support, she could purchase livestock and engage in animal husbandry. That was just the beginning.

She seized every opportunity to grow, attending skill enhancement programmes, learning all about managing livestock, and even attending workshops on parenting and children's rights. This whole experience sparked something in her, a determination that keeps pushing her forward.

Her hard work paid off, and her income soared. This transformation lifted her family from financial distress and ensured her children could continue their education. Venkataratnam's story is more than just an account of overcoming hardship; it is a testament to the power of support, resilience, and the deep bonds that tie us together. Her journey inspires others, showing that any obstacle can be overcome with the right support and a strong bond. This is just one of the several stories from our Family Strengthening Programme.



Kinship Care

Strengthening kinship: Fostering enduring bonds

Promoting parental care among next-of-kin families

The Kinship Care Programme ensures that children without parental care grow up with minimal educational, cultural and social disruption. Under this initiative, children who have lost their biological parents are cared

for by their extended families or relatives. We support the development of each child through our interventions, customised for each child's unique requirements, covering education, IT skills and personality development.

Adversity to aspiration: A journey of grit

Khushbu Raut is a young girl whose journey is full of love, support and determination. She lost her parents when her younger sister was just 11 months old. Despite this devastating loss, Khushbu, her sister, maternal grandmother and aunt formed a tight-knit, supportive family unit. The Ladli Laxmi Yojna, launched by the Government of Madhya Pradesh, became a turning point in Khushbu's life. This social scheme provided crucial financial support for her education, allowing her to continue her studies despite financial hardships. As the scheme celebrated its 15th anniversary, Khushbu was chosen to share her story, highlighting its impact on her educational journey.

In her speech, Khushbu requested additional support for meritorious girls who clear the JEE or NEET exams and urged the Chief Minister, Shri Shivraj Singh Chouhan, to waive professional course fees for beneficiaries after class 12. Her compelling plea led to a public announcement on May 2 2023, accepting her request and marking a significant milestone in the scheme's evolution.

Currently, Khushbu is in class 12 and preparing for the JEE exam in 2024. Despite her challenges, she remains determined and inspired by her family's love and support. Khushbu's story is a powerful reminder of how targeted social schemes can transform lives, enabling young girls to dream big and achieve their aspirations.



Taken in by their maternal aunt, Munni Devi, and paternal grandparents in Pidhauli Begusarai, the siblings struggled to make ends meet. However, Jiya's life took a hopeful turn when she joined the Kinship Care Programme, finding not just care but a community that believed in her potential.

With the support of mentors and tutors provided by the programme, Jiya regained confidence and excelled academically. Her determination led to outstanding performance in her Class 12 Board Examinations. Jiya was inspired to pursue a healthcare career based on her academic successes. She enrolled in a General Nursing and Midwifery (GNM) course at SOS Nursing School Faridabad, aiming to give back to the community that supported her growth.

Jiya's nursing journey marked a significant step in her life and inspired her younger brother, Aryan. Seeing his sister overcome numerous challenges and pursue her dreams motivated Aryan to aim high—he now dreams of becoming a doctor. The siblings draw strength from each other's ambitions, reinforcing their unbreakable bond.

Foster Care

Embracing security: Cultivating protection

Making way for quality childcare in certified foster families

Physical and emotional security are fundamental to a child's sense of well-being. A protective environment where children feel safe and loved is essential for healthy development. When children know they are secure, they can focus on growing, learning, and building positive relationships, fostering a sense of stability and confidence.

In response to the critical need for alternative care for abandoned or parentless children, SOS Children's Villages India has pioneered a community-based care solution through the Foster Care programme. This initiative places children in certified foster families we support, ensuring comprehensive development. It was launched in partnership with the Government of Meghalaya in 2021.

We ensure regular counselling during family visits and implement individual care plans to enhance child development. A comprehensive support system provides children financial assistance, healthcare, educational materials, and tuition. Simultaneously, the capacity of caregivers is bolstered through targeted training initiatives, including a curriculum for foster parents and interactive sessions on positive parenting skills. Training also covers maintaining Family House Registers, which is crucial for tracking budgets and expenditures, promoting transparency, and effective resource management.

Rising above struggle: A path of faith and success

Phromshon Myrboh, an 18-year-old under the care of his foster parent, Dralis Myrboh, in Wahshnong, East Khasi Hills District, Meghalaya, faced significant educational hurdles. When he joined the Foster Care Programme of SOS Children's Village Shillong at 15, he was in class 4. Understanding the challenges and age mismatch, his foster parent advocated for his direct admission to class 8. With dedicated support and personalised educational interventions, Phromshon embraced his studies, overcoming his reluctance and steadily progressing toward his academic goals.

With continuous support and encouragement, he not only completed class 8, but also discovered a passion for vocational training. Enrolling in a Wireman certificate course, his hard work and sincerity shone through, leading to an internship and eventually a job at B.E. Electricals in Shillong. Today, Phromshon is a thriving electrician earning a stable income. His transformation from a hesitant student to a successful professional is a powerful testament to his foster family's love, empathy and support, which brings immense pride and joy to everyone involved.

These situations threaten their immediate safety and have long-term impacts on their emotional and psychological well-being.

Understanding the urgent need for stability and support, we at SOS Children's Villages of India step in with the Emergency Childcare programme. This initiative provides immediate relief and a haven for children and families affected by crises. Tailored to meet the unique needs of each situation, the programme offers a blend of emotional support, healthcare, and educational resources.

Story of swift action and renewal

When the devastating floods hit Chennai, many families found themselves displaced and struggling to survive. Homes were destroyed, and communities, particularly children, grappled with the aftermath.

Our Emergency Childcare Programme brought light into the lives of children and their families during the chaos. Imagine the scene: relief camps, where dedicated workers met with families, listening intently to grasp what they needed urgently. The relief kits, thoughtfully prepared, included essential items such as food, water, hygiene kits, clothing, bedding and medical supplies. These efforts provided a lifeline to distressed families, bringing hope and stability in a time of chaos. These simple yet profound actions offered hope and stability for families whose worlds had been turned upside down. Through the turmoil, the programme has been a steadfast source of support, reminding us of the power of compassion in times of crisis.

United for flood-affected families

When the Yamuna River overflowed, causing severe flooding in Delhi, SOS Children's Villages India sprang to support affected families. The Delhi Disaster Management Authority's evacuation notice for riverbank residents highlighted the urgency. Children and women, the most vulnerable, were hit hardest by this natural disaster.

We provided crucial relief through the **Emergency** Childcare Programme. Understanding the critical needs, our officials visited relief camps in Mayur Vihar, speaking with families to assess their immediate requirements. With empathy and dedication, we prepared relief kits for 300 displaced families, focusing on essentials like dry rations, hygiene products and household items. Working closely with the District Administration, our co-workers and local volunteers ensured timely and equitable distribution of these kits. This compassionate response provided immediate relief and helped restore a sense of normalcy and security for the affected families, reinforcing the strong bonds within the community.

In addition to our relief efforts, we successfully established 'Childcare Space' with the local administration. This vital facility, launched during our relief efforts, provided a secure and engaging environment for 100 children under 10 in Mayur Vihar. Supervised by our dedicated women co-workers, the space was equipped with play materials, educational stationery and refreshments. This provision significantly alleviated the concerns of vulnerable families living in makeshift accommodations, ensuring that their children were safe and cared for, while the community worked towards recovery.

From fear to joy: A path to brighter days

Seven-year-old Aayat arrived at the SOS Short Stay Unit - Ashiyana, Nizamuddin-after a rough period. Her parents' separation and remarriages left her with grandparents, who soon faced marital discord. Due to this, she was forced to move to her maternal grandparents'. However, her maternal grandparents, facing financial challenges, failed to take care of her, leading to her placement at Ashiyana by the Child Welfare Committee. On her first day, Aayat was frightened and anxious. Her emotional state worsened when her grandmother left, but her housemother, Draupadi Bagade, and other caregivers provided immediate comfort. Despite health issues like nerve palsy, Aayat received the necessary medical

treatment and counselling, which helped her open up. Enrolled in a nearby school, she found joy in new books, uniforms and friends, transforming into a cheerful, carefree child.

Aayat's development flourished with the consistent care at Ashiyana. As her grandparents' situation improved, they wanted her back. After a thorough social assessment, Aayat was joyfully reunited with her maternal grandparents. Her journey at Ashiyana showcases the power of a nurturing environment, turning her life from fear to happiness.

Seeing Aayat's joy as she received new books, a school uniform, shoes and a school bag was priceless. Every day, watching her go to school and form bonds with her peers filled my heart with warmth and hope.

Youth Participation

From potential to power: Crafting futures today



Youth Participation is not a luxury treat we ask for, but something very important when working with young people. We know youth participation is not about always getting what they want. It is about powersharing between young people and adults, on small and big decisions, depending on our age and maturity.

Corporate and community engagement

Corporate partners play a pivotal role by engaging their employees and leveraging their networks to create tangible opportunities for youth. These partnerships are complemented by efforts to include young voices in policy-making, facilitated through platforms encouraging dialogue and participation. This dual engagement ensures that initiatives are well-rounded, addressing young individuals' professional and personal development.

National Youth Coalition 2023

On 19th and 20th October, 2023, a pivotal two-day meeting of the National Youth Coalition was held, gathering 23 representatives from various SOS villages. Led by former International Youth Coalition (IYC) members, Ms. Anadi and Dr. Ramesh, this annual conference produced significant findings and recommendations aimed at enhancing the involvement of children and young people in decision-making processes.

NYC Representatives in ACS 2023

During the ACS 2023 event, representatives from the 2023 National Youth Coalition presented key findings to all Village Directors. They discussed the current state of youth participation and proposed strategies to enhance engagement among management team decision-makers.

Local Youth Coalitions (LYC)

Following the National Youth Coalition 2023 recommendations, Local Youth Coalitions were established across all 31 locations to bolster youth participation. These LYCs serve as platforms for children and young people to voice their opinions on relevant issues. The initiation of LYC representatives included comprehensive training on child rights.

International Youth Coalitions (IYC)

Starting in 2024, three young representatives from SOS CV India will join the International Youth Coalitions, participating as members of IYC for a two-year term. This involvement underscores India's commitment to global youth advocacy and participation.

CYP Project | Child & Youth Participation (CYP) in Safeguarding

The Child & Youth Participation (CYP) initiative focuses on safeguarding and promoting the active involvement of children and young people in protecting their rights and participating in decision-making processes that affect their well-being. Following the participants' validation of assessment results, the final report prepared by our external consultant, Dr. Vikram, was shared with Village Directors. This report includes key findings and recommendations to enhance youth participation in safeguarding measures and ensure effective implementation.

Youth Power 3.0 Empowering Youth Initiatives

In 2023, three dynamic youth-led initiatives were selected to empower young individuals and foster community engagement: Zero Waste Management in Cochin, Support for Care Leavers in Srinagar, and Eco-Bricks in Anangpur. Six youths and three co-workers, guided by the Youth Engagement Specialist, participated in a refresher training session conducted by external mentors from Change-makers Xchange. This training aimed to build capacity and strengthen their initiatives. Collectively, these programmes engaged around 500 young people and adults, inspiring them to become proactive changemakers in their communities.

Youth Can!

Mentoring and training programmes

BorgWarner India Initiative

On 18th November 2023, we organised a half-day physical session at Greenfields CV, facilitated by our dedicated volunteers from BorgWarner. The session engaged 25 young participants, equipping them with vital employable skills such as career selection, interview techniques, communication skills, and teamwork.

Baringa U.K. Virtual Sessions

During October and November 2023, we hosted two virtual sessions in collaboration with Baringa U.K., focusing on self-awareness and interview skills for management consulting. These sessions were attended by 150 youths from FLC and SGH; and an additional 75 from SIL participated in group mentoring, led by three expert volunteers from Baringa Global to enhance their readiness for management consulting roles.

TKE Partnership Meeting

Key visitors from TKE & CEO, SOS India, met with Youth Can Participants and settled youth (Physical & Virtual) at SOS CV Greenfields. The settled youth shared their experience with the Youth Can! Programme experiences and discussed the way forward. Three 3-day workshops on employability skills were organised with 80 young people in August 2023 and February 2024.



Comprehensive mental health care and supportive interventions are critical to help these children overcome their past experiences and foster resilience, allowing them to develop into well-rounded individuals with a hopeful outlook on life.

In our extensive network of over 50 programme locations throughout the country, we have identified 142 children at risk of potential self-harm, some of whom were already under treatment for pre-existing mental health conditions. To address their needs effectively, these children have been referred to specialised facilities where they receive comprehensive support, including counselling and when necessary, medication interventions. This targeted approach ensures that each child receives the appropriate care tailored to their specific mental health requirements, fostering a safer and more supportive environment for their recovery and well-being.

Child safeguarding Child rights and equality

At SOS Children's Villages India, our foremost commitment is to provide a secure, safe and nurturing environment for every child in our care. We strictly adhere to international standards and local legislations, ensuring that the children feel safe, valued and respected.

2023 was a year of learning and spreading awareness on revised policies and regulations, wherein SOS Children's Villages India introduced the Child and Youth Safeguarding Policy along with other relevant policies like Misconduct incident Management regulations and revised Code of Conduct policy. A guideline on visiting regulations was introduced, which brought in details of safeguarding while a visitor is welcomed in the programme location.

Raising awareness

Conducted across various locations, these sessions educate caregivers and children on sustainable lifestyles, climate change, and environmental responsibilities. Specific topics covered include cyber safety, gender studies, and mental health, with materials translated into local languages for accessibility.

Prevention through



In line with the 12th article of UNCRC, SOS India actively promotes child and youth participation in its safeguarding efforts. To ensure that their voices are heard, there are youth led initiatives and coalitions. There are regular online interactions between the National Child Safeguarding Focal Person (CS-NFP) and leaders of children and youth clubs from Family-Like Care (FL), Small Group Homes (SGH), and Semi-Independent Living (SIL) programmes.

The primary objective of this initiative is to empower children and young people to discuss safeguarding practices, review annual safeguarding reports, identify trends, root causes, and actively participate in developing child-friendly safeguarding initiatives. Each Children's Village has three Children's Committees (6-10 years, 11-15 years, and 16-18 years) and every SGH has one youth group (14-18 years age) who elect a leader to participates in interactions with CS-NFP.

The first meeting with leaders from Local Youth Coalitions took place during, 'Child Rights Week' in 2023, where the concept was introduced. Based on their decision to

have these meetings quarterly, the second meeting was organised in February 2024, with their active participation. Leaders discuss the topics from these meetings in their monthly club gatherings to ensure their peers are equally informed. For SIL young adults, bi-annual meetings are planned to address their specific concerns.

This initiative has had significant outcomes and impacts. Children and young people are empowered to raise safeguarding-related issues directly with the national focal person and to advise on child-friendly safeguarding processes. As a result, they have the opportunity to participate in safeguarding processes and address their concerns diectly. Young people influence decisionmaking on the design and implementation of child-friendly activities, acting as agents of change and role models for their peers. This initiative ensures that children and young people are actively involved in shaping the safeguarding practices that affect them, promoting a culture of safety, empowerment, and proactive participation.

risk mitigation In 2023, SOS India successfully completed the risk assessment and established the Incident Management Team demonstrating a proactive commitment to safeguarding principles, ensuring that potential risks are identified, addressed, and managed effectively to protect vulnerable individuals and uphold organisational integrity and values. The local mapping at all 31 locations and their mitigation plans were mapped and monitored on regular intervals with the participation of children and caregivers. This integrated approach strengthens safeguarding systems and contributes to a safe and supportive environment for all stakeholders involved in project activities.

Our Vocational Training Centre offers tailored programmes in agriculture and horticulture, equipping children with valuable skills that align with their interests and abilities. Simultaneously, our comprehensive Medical Centre ensures access to necessary medical treatments, alongside therapeutic

services such as speech, music, and occupational therapies. This robust framework supports the children's physical well-being and their vocational aspirations, fostering well-rounded development in a nurturing setting.

The role of 'SOS Mothers' is pivotal. These dedicated caregivers undergo specialised training to adeptly support the unique needs of each child, focusing on emotional nurturing, skill development, and personal care. Their training includes comprehensive developmental approaches that cater to the psychological and physical aspects of child care. This specialised training enables the SOS Mothers to take care of children who are bedridden, providing a warm, supportive environment that encourages the children's overall growth and well-being.

A tale of hope and resilience

Rahul and Nikhil were pretty much inseparable from the moment they set foot in our village. Both came with their own challenges—Rahul battling cerebral palsy and Nikhil challenged with hyperactivity. Barely seven years old, they carried this immense feeling of loneliness with them.

They quickly discovered the power of friendship here, which wraps you up in warmth and makes you feel like you belong to a big, loving family. It was this bond and love that transformed everything for them. They began dreaming big, fuelled by the support and affection they found. 

Capacity-building initiatives

Mothers workshop (Zone 02): The worshop was attended by numerous Mothers/Aunts who received updates on the changing organisational scenario, new Code of Conduct and Living Our Values (LOV). The workshop included sharing of inspiring success stories, earning a feedback rating of 96.25%.

Customised induction plan: Developed for management trainees in Family Strengthening (FS) and Family Like Care (FL), enhancing their onboarding experience.

Online training modules: Launched sessions on Code of Conduct and Living Our Values, now accessible online.

Mother's zonal workshops: Conducted in-person with 150 participants, focusing on direct engagement and skills enhancement.

Training coverage: Achieved 69% for Mothers and 65% for co-workers, reflecting our commitment to continuous professional development.

Annual co-workers seminar: Held in December 2023 with 79 participants, aimed at reinforcing team cohesion and strategic alignment.

Automation and system enhancements

HRMS upgrade: Launched HRe Connect 2.0, incorporating online recruitment, Performance Management System (PMS), confirmation, and exit modules.

Employee self service: Enabled active data updates for co-workers, improving data accuracy and accessibility.

Enhancing operations through strategic ICT initiatives

The ICT Function implemented a comprehensive strategy that focused on both technological advancements and human capital development to enhance the efficiency and responsiveness of our ICT operations. A significant step was the introduction of Managed IT Services, which streamlined our IT infrastructure and provided expert support. Additionally, we established a new end-user support team comprised of skilled engineers, ensuring timely and effective assistance to our staff.

Furthermore, we prioritised the professional development of our ICT focal persons, empowering them with enhanced responsibilities and fostering a culture of greater involvement. By equipping them with the necessary tools and training, we aimed to cultivate a more engaged and proactive team.

We optimised our ICT expenditures by engaging in strategic negotiations with service providers, securing more favorable terms and conditions. Moreover, we implemented rigorous project management practices to ensure that IT purchases were made at competitive prices.



Innovating procurement | Launch of a new digital management system

SOS India made significant strides in enhancing our procurement processes by developing, testing and rolling out a new software module to digitise, automate and ensure transparent management of procurement activities. This cutting-edge system, which became operational towards the end of the year, is now the standard for processing all new procurements of products and services within our organisation as we move into 2024-2025.

Revolutionising our operations | The new SIS software application roll-out

This year, we proudly rolled out a new SIS software application, a key component of our Enterprise Resource Planning (ERP) system. This significant update included a complete structural makeover of the Expense Authorisation System and other crucial elements of the SIS application. This transformation was essential to align our financial and accounting systems with the new Dynamics 365 system implemented at SOS IO.

The revamped SIS application is now developed to embrace the Results-Based Management (RBM) approach. Unlike the previous system, where SIS (SOS India) and Navision (SOS IO) operated independently with no data interchange.

Advancing IT management | Deployment of Lansweeper Automation System

We initiated the deployment of a sophisticated software-based, automated IT inventory discovery and management system across all SOS India facilities. To facilitate this advancement, we have introduced Lansweeper, a new tool that will replace the previous manual inventory tracking and reporting system fraught with inherent flaws.

This transition to an automated system will significantly enhance our efficiency in managing IT assets, ensuring more accurate and reliable inventory control.

Technology uplift at Hermann Gmeiner Schools

The technological infrastructure at Hermann Gmeiner Schools has seen significant enhancements, ensuring that our educational environments are equipped with the latest digital learning tools like interactive LED panels across all HGS, stable and high speed internet, ehanced online security; and communication & collaborations tools have been introduced.

Managed IT Services

We have successfully completed the deployment of Managed IT Services, a critical enhancement to our IT infrastructure. This comprehensive service includes round-the-clock monitoring and alerting our data centre in National Office and essential network devices across various projects. The scope of these services extends beyond mere oversight; it encompasses routine server maintenance, robust security measures, and meticulous management of data backup.



Strategic alliances **Government partnerships** and schemes

In the 2023-2024 period, SOS Children's Villages India engaged in several notable Government partnerships across various states to enhance the support systems for families and children. The 'Sankalp Saptaah Programme' launched by the Prime Minister and the PM SVANidhi scheme facilitated the formalisation of street vendors under the National Urban Livelihood Mission.

In Guwahati, Assam, collaboration with the Indian Institute of Entrepreneurship under the Ministry of Skill Development and Entrepreneurship focused on skill development. In Hojai, Assam, families benefited from the ORUNODOI scheme under GoAssam, while in Kolkata, children received bicycles under the 'Sabooj Sathi' scheme by the Government of West Bengal.

In Latur, an entrepreneurship training programme was conducted in collaboration with MSME, the Government of Maharashtra to educate on livelihood schemes.

FS Bhopal organised a 'Bal Mela' in cooperation with local NGOs, NIWCYD, UNICEF, and the WCD to promote cultural and educational activities.

Additionally, a new digital learning centre was set up in Raggiguda, Bengaluru, with contributions from the Government of Karnataka and the Rotary Club. In Bihar, child rights sessions were held by the Block Development Officer, and in Chennai, the Kalaignar Scheme addressed the rights of women. Environmental initiatives were also significant, with Assam launching the Amrit Brikshya Andolan-2023 to plant one billion seedlings to enhance state greenery; and in Chennai, the Government of Tamil Nadu backed the planting of one crore palm trees, involving various local associations and volunteer groups.

In Shillong, Meghalaya, an awareness session on climate change was conducted for our children by the Botanical Survey of India, illustrating a broad commitment to environmental education and community involvement.


Sources of Funds
